On

Enforcement of Technical Standards of Infrastructure to Facilitate the Accessibility of Disabled Persons

- Having seen Sub-Decree No. 86 ANK.BK dated 19 December 1997 on Construction Permit
- Having seen Sub-Decree No. 42 ANK.BK dated 03 April 2015 on Urbanization of Capital, City, and Urban Area
- Based on the urgent need of the Ministry of Social Affairs, Veterans, and Youth Rehabilitation and the Ministry of Land Management, Urban Planning, and Construction.

Decides

Article 1:

Place into force the Technical Standards of Infrastructure to Facilitate the Accessibility for Disabled Persons as attached in the Annex of this Prakas.

Article 2:

The Technical Standards of Infrastructure to Facilitate the Accessibility for Disabled Persons shall be enforced on the construction project and the adjustment of public infrastructure buildings that provide public services and public space including road network, sidewalk, pavement, park, parking lot, train station, airport, administrative building, school, educational institution, hospital, health centers, infrastructure construction project, gated community (Borey), residential buildings, hotel, restaurant, market, factory, and other private building for disabled persons in Cambodia in order to ease the accessibility of the disabled person with safeties and unobstructed.

Article 3:

Unit or institution who has the competence to issue the construction permit must require the construction owner to include the infrastructure that eases the accessibility of disabled person to enter-exit, to move up-down and uses for instance entrances and passageways, ramps, visible signs, slope, walkway, safe handrail, staircase, door and doorknob, stair, elevator and the elevator button, escalator, travelator, audible alert device, in-door passageway, rest lounge, sign, traffic sign, counter service, accessible toilet, urinal, handwash sink, water source, hand pump, shower room, equipment in classroom or conference room and other safety equipment in accordance with the Technical Standard as attached in the Annex of this Prakas.

Article 4:

Any contradict provision to this Prakas shall be abrogated.

Article 5:

Chief of Staff, Director General, Chief of Building, Head of Institution under the Ministry of Land Management, Urban Planning, and Construction and Ministry of Social Affairs, Veterans, and Youth Rehabilitation, General Secretariat of Council of Disabled

Persons Action, Provincial/Capital Governor, City/District/Khan Governor shall hold the responsibility to enforce this Prakas upon the date of signature.
